- a. Certificate of Incorporation (Business Registration Certificate)
- b. Form 1, 40 or other equivalent as applicable
- c. Form 20 if applicable only
- d. Form 13 or other equivalent (if applicable only)
- e. Articles of Association
- f. Board resolution (through the company secretary) authorizing the signatory to sign the Agreement according to LCPL format or certified copy of Power of Attorney empowering the signatory/ies to sign the Agreement

3. Corporate documents required for signing agreements from sole proprietary/partnership companies in Sri Lanka

Following must be certified true copies by an Attorney-at-Law:

- a. Certificate of registration of the company
- b. Copy of the NIC or Passport or Driving License of the sole proprietor or partners
- Power-of-Attorney or Statement of Signatures according to LCPL format authorizing the signatory to sign the Agreement (For partnership companies only)

4. Corporate documents required for signing agreements from foreign companies

Following must be certified true copies by an Attorney-at-Law or Company Secretary

- a. Business Registration Certificate
- b. Director confirmation Form
- c. Address confirmation Form
- d. Power-of-Attorney or Board resolution or letter of authority according to LCPL format authorizing the signatory to sign the Agreement (through the company secretary or an Attorneyat-Law)

5. Documents required for signing agreements from Banks

Following must be certified true copies by an Attorney-at-Law:

License from the Central Bank

6. Documents required for signing agreements from Government Institutions

- Authority of Establishment, ex Act of Parliament, etc.

Documents required for signing agreements for Individuals

Following must be certified true copies by an Attorney-at-Law:

a. Copy of the NIC or Passport or Driving License
